

Terms & Conditions Senoko Energy Q1 2024 GIRO Promotion – GIROWATTS30 Promo Code

- These terms and conditions shall apply to the promotional code ("promo code") "GIROWATTS30" provisioned by Senoko Energy Supply Pte Ltd.
- 2. The promo code entitles you to enjoy a **one-time \$30 bill rebate** off your Senoko Energy electricity bill and is **valid from 5 Jan 2024 to 4 Apr 2024, both dates inclusive**.
- 3. The promo code is applicable to both **New Sign-Ups & Renewal of Senoko Energy's 12-month fixed rate**, **discount-off tariff** and **discount plans**.
- 4. Under this promotion, an eligible Senoko Energy customer can get a **one-time bill rebate** if he/she sign-up or renews for a **twelve (12) months** Senoko Energy residential electricity price plan ("Senoko Energy Plan") via a promo code "**GIROWATTS30**" ("Promo Code") and successfully sets up payment for the Senoko Energy Plan on a **recurring basis through GIRO**, by the relevant stipulated dates in Table 1 below.

- 5. An eligible Senoko Energy customer will receive a **one-time bill rebate of \$\$30** by the dates indicated in Table 1, depending on their service sign-up or renewal date and recurring payment set up date.
- 6. To apply a promo code, you must enter it at check-out prior to completing your registration.
- 7. To enjoy the bill rebate associated with the promo code, the full contractual period will have to be fulfilled. Early termination of contract may result in a reversal of benefits.
